You also agree that:

- b. Submitted images may be used in articles in other publications in connection with CMHA Manitoba Division.
- c. Copyright is retained by the artist and the use of such art by CMHA is limited or restricted to those described in these terms and conditions. CMHA may not grant use of the art to third parties.
- d. The Kaleidoscope: Wellness Through Creative Expression Magazine Committee reserves the right to reject any submission without showing cause (in which case, neither NSS nor its chapters may use that submission for any purpose without the specific separate permission of the artist).
